Foreign passport holders, permanent migrants and temporary visitors – TFN application

You can apply for a tax file number online if you meet these three conditions:

1. You are a foreign passport holder, permanent migrant or temporary visitor.
2. You are already in Australia.
3. Your visa is one of the following:
 - > a permanent migrant visa
 - > a visa with work rights
 - > an overseas student visa
 - > a visa allowing you to stay in Australian indefinitely (including New Zealanders automatically granted a visa on arrival).

Tax file number application or enquiry

Who can apply for a tax file number online?

You can apply for a tax file number (TFN) online only if you are currently in Australia and you have:

- a valid permanent migrant visa
- a valid visa with work rights
- a valid overseas student visa
- a valid visa allowing you to stay in Australia indefinitely.

Only one TFN will ever be issued to you. Once you have a TFN, you don't need to re-apply for one if your circumstances change, for example, if you change your name, have investments or claim government benefits.

If you know your TFN but wish to advise the ATO of changes to your details, you can update some details online if you have a myGov account linked to the ATO, or refer to [updating my details](#) on our website.

If you already have a TFN, complete this application if:

- you want to know what your TFN is and your details have changed since you last applied
- you would like a copy of your TFN advice
- you need to confirm your identity details with the ATO.

Your TFN will then be sent to you.

If you do not speak English well and need help from the ATO, phone the Translating and Interpreting Service on **13 14 50**. If you are deaf or have a hearing or speech impairment, phone the ATO through the National Relay Service (NRS) on the numbers listed below:

- Speak and Listen (speech-to-speech relay) users – phone **1300 555 727** and ask for the ATO number you need

TFN application for temporary visitors and permanent migrants

The following pages will take you through the registration process to apply for an Australian tax file number (TFN). You do not require a TFN to work in Australia, but it is to your advantage to have one. If you do not, you may pay higher tax and have no entitlement to government benefits that you may otherwise be eligible for. Residents and temporary visitors are required to pay taxes on income earned in Australia.

Visitors and permanent migrants need authorisation from the Department of Immigration and Border Protection (DIBP) to work in Australia. Note - solely receiving a TFN is not an authorisation for you to work in Australia.

You must be in Australia to use this online application process.

During this application process, checks will be made with DIBP to verify that you have:

- a valid permanent migrant visa
- a valid visa with work rights
- a valid overseas student visa
- a valid visa allowing you to stay in Australia indefinitely.

If you do not have one of the valid visas listed above, exit now - you are not entitled to apply for a TFN via this application. If you believe you should have such a visa, contact your nearest DIBP Office. A list of offices and further information on visas and work rights can be found on the DIBP website at www.immi.gov.au.

If you were born in Australia or have taken out Australian citizenship, you cannot use this service. Go to [Australian residents – TFN application](#).

What will you need to complete the application?

Applying for a TFN should take about 20 minutes. You will be asked to enter personal details, including your passport or travel document number, a postal address in Australia where your TFN can be sent, your legal name and other names you use or have used and contact details for yourself or your preferred contact person.

It is not an offence not to quote your TFN, but not quoting it may delay us in either helping you with your enquiries or processing this application.
